After their discussion Mr. Ward contacted Johnson Township Fiscal Officer Suellen Slayton and asked if she would serve as Interim Fiscal Officer for Mad River Township. Mrs. Slayton agreed to serve until a new Fiscal Officer can be hired by Mad River Township. Fiscal Officer Slayton will receive an hourly rate of pay for her services. The hourly rate has not been decided at this time. Motion to hire Suellen Slayton was made by Brent Laughman. David Riley seconded the motion and on the roll being called the vote was: Ward, Yes; Riley, Yes; Laughman, Yes. Motion carried.
