## Minutes and Financials

**Motion:** Brent Laughman motioned to approve minutes and financials/bills/checks. Dave Riley seconded motion. Motion passed unanimously.

-Trustees discussed the PTO on the road tractor that needs repaired. They agreed to have Warman's Garage repair it.

-Trustees discussed the windshield on the 4900A truck. It apparently is scratched up to the point it is difficult to see out clearly.

**Motion:** Dave Riley motioned to replace the windshield on the 4900A. Brent Laughman seconded the motion. Motion passed unanimously.

-Trustees updated that the mowers have been cleaned up for winter storage.

-Brent Laughman asked Mr. Ward if he had followed up with Mr. Steinberger on the status of the Zoning Board files that had been pending since 2014. Mr. Ward had not talked to him so he attempted to call Mr. Steinberger during the meeting, but had to leave a message. Mr. Ward to follow up with him.
