# Roads and Bridge

-Trustees discussed putting a rejuvenator/sealer on Coffin Station Road once the asphalt project is completed. County Engineer recommended using. He uses it on all new roads that the County puts in.

**Motion:** Mr. Riley motioned to approve the rejuvenator for Coffin Station Road. Mr. Laughman seconded the motion. Motion unanimously approved.

-Mr. Laughman said we had an estimated date to start Coffin Station around July 20.

#### Cemeteries

- -Mr. Laughman said they have completed the cemetery foundation bases.
- -Mr. Laughman said we have a door on the building at Terre Haute that is rotting. Mr. Hoblit quoted repairing it for \$425. **Motion:** Mr. Riley motioned to approve Mr. Hoblit to repair the door. Mr. Laughman seconded the motion. Motion unanimously approved.

# Equipment

-No updates

### Zoning

-Mr. Laughman said Bob Purk sent an email update on zoning. The update said that the camping resort on Coffin Station Road does not comply with the zoning rule nor is allowable as a conditional use.

#### Other Administrative

-Trustees discussed fixing the front door to the township building. Mr. Laughman said Jeff Hoblit estimated it would cost about \$125 to fix it.

**Motion**: Mr. Riley motioned to have Jeff Hoblit fix the front door. Mr. Laughman seconded the motion. Motion unanimously approved.

-Mr. Ford updated trustees that we have received the CARES Act Relief Funds totaling \$11,619.11. He said the trustees need to adopt an amendment to our Appropriations measure to allow for spending of this amount.

**Resolution**: Mr. Riley motion to adopt the Amended Appropriations for the new Coronavirus Relief Fund (fund number 2272) to match the Federal CARES Act grant amount of \$11,619.11 for Fund/Program 2272-490. Mr. Laughman seconded the motion. Motion unanimously approved.

- -Mr. Riley said he has asked Evans electric to provide a quote for putting electric for hand dryers to help prevent spread of germs in the bathrooms.
- **-Motion:** Mr. Riley motioned to adjourn the meeting at 7:18pm. Mr. Laughman seconded motion. Motion passed unanimously.
